### *Rebates for energy efficiency improvements*

*Braintree Electric Light Department (BELD) is pleased to offer assistance to customers making energy efficiency improvements to their homes. Learn what measures make sense for your home by calling our Home Energy Advisor Service at 781.348.1032. You'll get information that can start saving you energy right away, and if you're thinking about making upgrades to your house, we'll do an Energy Audit and provide you with a list of recommendations. Complete any of the qualifying work, and we'll pay for half of it—up to \$1000!*

#### ***Who can apply for a rebate?***

Any current BELD customer who has received an Energy Audit through our Home Energy Advisor Service.

#### ***What measures are eligible?***

To qualify for a rebate, the project **must come from recommendations made during the Energy Audit**. Eligible measures include:

- Attic insulation, including ventilation
- Wall insulation
- Rim joist insulation
- Air sealing measures
- Window treatments, including interior storms
- Pipe and duct insulation
- Heating system upgrades (call for specific requirements)
- Setback thermostats
- Domestic hot water heating upgrades
- Renewable energy installation (solar, wind)

*Sorry, replacement doors and windows are not eligible under this program.*

#### ***Who does the work?***

Work can be done by the homeowner, a contractor, or a combination of the two. Where applicable, the contractor must be licensed for the work performed.

#### ***How much is the rebate?***

50% of the total job cost, including materials and labor, or \$1000—whichever is less. Please allow 4-6 weeks for processing. Limit one rebate per customer per calendar year.

#### ***How can I apply for the rebate?***

You must fill out an Application for the Energy Smart Home Rebate (see reverse), available at our Customer Service desk at 150 Potter Road or online at [www.beld.com](http://www.beld.com).

***Each application must be accompanied by the original sales receipt for any materials purchased and/or the final invoice from any contracted work. Proof of payment is also required.***

BELD reserves the right to inspect or otherwise verify installation of any and all energy-saving measures.

BELD reserves the right to change any portion of this program, or end this program, at any time without notice. Rebates are limited based on annual budget. If you have any questions, please call the Energy Advisor at 781.348.1032 before beginning any project.
